**NOTICE OF AVAILABILITY OF NEW PRELIMINARY DRAFT OF NUREG-0645/FEMA-REP-1
AND NOTICE OF JUNE 25, 2014, NRC PUBLIC MEETING TO DISCUSS CHANGES TO THE
PRELIMINARY DRAFT (FSME-14-064)**

Purpose: To provide notice that the U.S. Nuclear Regulatory Commission (NRC) and the Federal Emergency Management Agency (FEMA) will be hosting a category 3 public meeting to discuss preliminary draft changes to NUREG-0654/FEMA-REP-1, "Criteria for Preparation and Evaluation of Radiological Emergency Response Plans and Preparedness in Support of Nuclear Power Plants."

Background: A joint NRC/FEMA Writing Team is in the process of revising NUREG-0654/FEMA-REP-1. The revision process will involve restructuring and streamlining the document to focus on the evaluation criteria relevant to both onsite and offsite emergency preparedness programs.

Discussion: A new preliminary draft of NUREG-0654/FEMA-REP-1, "Criteria for Preparation and Evaluation of Radiological Emergency Response Plans and Preparedness in Support of Nuclear Power Plants," (Agencywide Documents Access and Management System (ADAMS) Accession No.: [ML14163A605](#)) is now available at: https://adamsxt.nrc.gov/WorkplaceXT/getContent?id=release&vsId=%7BAAB72036-A82F-4DC7-AA12-C5563B7730AB%7D&objectStoreName=Main_Library&objectType=document. The public meeting discussion will focus on Section I, "Introduction," and stakeholder feedback specific to this section. A general overview and discussion of changes to Section II, "Planning Standards and Evaluation Criteria," based on previous stakeholder feedback on this section will also be conducted.

The meeting will take place on Wednesday, June 25, 2014, 12:30 pm – 4:00 pm EDT.

The location will be at the Advisory Committee for Reactor Safety Hearing Room (T-2B3) in Two White Flint North at NRC Headquarters, located at 11545 Rockville Pike, Rockville, Maryland.
