OPPORTUNITY TO COMMENT ON DRAFT NUREG-1556, VOLUME 18, REVISION 1, "CONSOLIDATED GUIDANCE ABOUT MATERIALS LICENSES: PROGRAM-SPECIFIC GUIDANCE ABOUT SERVICE PROVIDER LICENSES" (FSME-14-068)

Purpose: To provide the Agreement States with the opportunity to comment on the Office of Federal and State Materials and Environmental Management Programs draft NUREG-1556, Volume 18, Revision 1, "Consolidated Guidance about Materials Licenses: Program-Specific Guidance about Service Provider Licenses."

Background: The U.S. Nuclear Regulatory Commission (NRC) is revising the licensing guidance in the NUREG-1556 series. The NRC originally published NUREG-1556, Volume 18, in November 2000. The document is intended for use by applicants, licensees and NRC staff, and is also available to the Agreement States.

Discussion: NUREG-1556, Volume 18, Revision 1, has been updated by a working group made up of NRC and Agreement State representatives, to include safety culture, security of radioactive materials, protection of sensitive information and changes in regulatory policies and practices.
