UPDATED INFORMATION REGARDING THE PUBLIC MEETINGS/WEBINARS TO
DISCUSS POTENTIAL CHANGES TO 10 CFR PART 20, STANDARDS FOR PROTECTION
AGAINST RADIATION (STC-14-102)

Purpose: To provide the Agreement States, Non-Agreement States, and State Liaison Officers updated information relative to the public meetings/webinars on the potential changes to regulations in Title 10 of the *Code of Federal Regulations* (10 CFR) Part 20, "Standards for Protection Against Radiation."

Background: As discussed in [FSME-14-076](#), "Opportunity to Comment on Potential Changes to 10 CFR Part 20, Standards for Protection against Radiation," dated September 19, 2014, the U.S. Nuclear Regulatory Commission (NRC) planned a series of public meetings to discuss the Advance Notice of Proposed Rulemaking (ANPR) for potential changes to 10 CFR Part 20 that was published in the *Federal Register* (79 FR 43284) on July 25, 2014. Discussion: At the present time, the NRC staff has completed four public meetings/webinars to discuss the Part 20 ANPR. A fifth public meeting was scheduled for October 23, 2014. Based upon the level of participation, the NRC has decided to cancel the fifth public meeting.
