PROPOSED INTEGRATED MATERIALS PERFORMANCE EVALUATION PROGRAM
SCHEDULES FOR NRC FISCAL YEARS 2025–2027 (STC-24-025)

Purpose: To inform U.S. Nuclear Regulatory Commission (NRC) and Agreement State radiation control programs of the Integrated Materials Performance Evaluation Program (IMPEP) review schedule for NRC fiscal years (FYs) 2025 through 2027 and to solicit comments on the proposed schedule.

Background: Annually, the NRC provides the projected IMPEP schedule to the Agreement States to ensure that NRC and Agreement State personnel have advanced notice of upcoming IMPEP reviews.


