NOTIFICATION OF THE U.S. NUCLEAR REGULATORY COMMISSION "IMPLEMENTATION PLAN FOR THE FUTURE OF THE NATIONAL MATERIALS PROGRAM WORKING GROUP AND WORKING GROUP TO ASSESS THE ABILITY TO MONITOR NATIONAL MATERIAL PROGRAM PERFORMANCE" (STC-25-001)

**Purpose:** To inform the States that the U.S. Nuclear Regulatory Commission (NRC) has published the "Implementation Plan for the Future of the National Materials Program Working Group and Working Group to Assess the Ability to Monitor National Material Program Performance."

The NRC staff has developed an Implementation Plan to address these two working group reports.

**Discussion:** To address these two working group reports, the Implementation Plan for the joint NRC and Agreement State working groups: the Future of the NMP Group and the Working Group to Assess the Ability to Monitor NMP Performance can be found at [ML24225A146](#). This Implementation Plan, based on the suggestions provided by the working group reports, outlines the Division of Materials Safety, Security, State, and Tribal Programs (MSST) management's recommendations and decisions. Although these working groups had separate goals and purpose, both provide recommendations to promote increased coordination across the NMP and therefore are considered for implementation concurrently.
