ANNOUNCEMENT OF JUNE 24-25, 2025, STATE LIAISON OFFICER CONFERENCE
(STC--25-010)

Purpose: To notify all States of the U.S. Nuclear Regulatory Commission (NRC) intent to hold an in-person State Liaison Officer (SLO) conference in Rockville, MD, on June 24-25, 2025.

Background: Approximately every 2 years, the U.S. NRC convenes a meeting with all SLOs to discuss issues of interest to the States and the NRC in the areas of nuclear regulation, nuclear security, radiological public health and safety, and environmental issues. This meeting provides a unique opportunity to discuss issues of mutual interest with representatives from multiple States and NRC senior management.

Discussion: The NRC will fund the travel of each SLO (or one designated representative) to attend the 2025 National State Liaison Officer Conference, which is scheduled for June 24-25, 2025, at the at the NRC headquarters building in Rockville, MD. Please provide the selected individual's name, telephone number, and e-mail address to ASTrainingandtravel.Resource@nrc.gov no later than Friday, April 11, 2025. Travel instructions will follow within 8 weeks prior to the meeting.

Some of the topics and panels under development for inclusion in the conference include:

- Updates on the NRC's progress in implementing the ADVANCE Act of 2024;
- New reactor applications, reactor restart applications, and pre-application engagement with the industry;
- Emergency planning for advanced/small modular reactors;
- Fusion machines rulemaking and guidance; and
- NRC Commissioner and Senior Leadership Panels.

As we have endeavored in the past SLO conferences, we are striving to ensure the 2025 conference and topics will be structured to maximize the benefits and interests of you, our state partners.
