**NOTIFICATION OF CHANGE TO INVITATIONAL TRAINING AND TRAVEL IDENTIFICATION
REQUIREMENTS FOR NRC-SPONSORED COURSES PARTICIPANTS AND OTHER
INVITATIONAL TRAVEL (STC-25-027)**

Purpose: To provide notification to the States of changes for invitational training and travel identification requirements for participating in NRC-Sponsored courses and other invitational travel provided by the U.S. Nuclear Regulatory Commission (NRC).

Background: The NRC provides funding to the Agreement States for training and the associated travel. The NRC also provides funding to States for Annual Meetings which can include the Organization of Agreement States Meeting, State Liaison Meeting and Commission Meetings, etc., and Integrated Materials Performance Evaluation Program (IMPEP) participation. Effective immediately participants will be required to provide REAL ID compliant identification for not only entering federal training facilities but also to board domestic flights. If you cannot provide this, you may not be able to attend NRC-Sponsored courses or other invitational travel.

Discussion: Beginning May 7, 2025, every state and territory resident will need to present a REAL ID compliant license/ID, or another acceptable form of identification, for accessing federal facilities, entering nuclear power plants, and boarding commercial aircraft. The card, itself, must be REAL ID compliant unless the resident is using an alternative acceptable document such as a passport or passport card, or state-issued Enhanced Driver's License. The Act does not require individuals to present identification where it is not currently required to access a federal facility (such as to enter the public areas of the Smithsonian) nor does it prohibit an agency from accepting other forms of identity documents (such as a U.S. passport or passport card).
