2025 (STC-25-029)

Purpose: To provide the U.S. Nuclear Regulatory Commission (NRC) additional sponsored training opportunity for Inspection Procedures (G-108) Course available to Agreement States' staff for fiscal year 2025 and initiate the application process.

Background: The NRC will fund training and associated travel for Agreement State staff to attend this course sponsored by the NRC.

Discussion: The NRC is offering an additional Inspection Procedure (G-108) course, September 22-26, 2025, in Orlando, Florida. This offering will be State delivered by the Florida Agreement State. There is limited space available for this offering. Please note, there is another Inspection Procedure (G-108) course being offered at the NRC's Technical Training Center in Chattanooga, TN, for Agreement States in early September.

Please complete and submit a training application(s), located on our website ([AS Training](#)), for each individual, including priority. Applications must be submitted by July 25, 2025. A letter of acceptance will be issued within a week after the application due date. Priority is not given to early applicants, as all applicants will be considered at the due date. The letter of acceptance will contain specific guidance relating to travel and per diem and will provide the students with information relating to their responsibilities. Upon acceptance, if an individual is no longer available to attend the course, notification **must** be provided immediately so that individual can be replaced.
