## INSTRUCTIONS TO STUDENTS

**ACCEPTANCE:** This is to advise you that those individuals listed in Enclosure 1 have been accepted for participation in the 2014 NRC Sealed Source and Device Evaluation Workshop. This workshop is scheduled to take place from March 31 - April 4, 2014, at the Embassy Suites Cincinnati – River Center. The Embassy Suites is located at 10 E Rivercenter Blvd, Covington, Kentucky 41011. The facility's telephone number is (859) 261-8400.

**COURSE:** Workshop activities will begin on Monday, March 31, 2014 at 8:30 a.m. and will conclude at 12:00 p.m. on Friday, April 4, 2014. Enclosure 3 is a tentative agenda for the workshop.

**LODGING AND TRAVEL:** You should plan to arrive on Sunday, March 30, 2014, and depart on Friday, April 4, 2014. Participants must make their own lodging and travel arrangements. The NRC has reserved a block of rooms at the Embassy Suites Cincinnati – River Center at the Federal Government rate of \$127.00 night. To ensure you receive this rate, you must make your reservations by March 10, 2014. Reservations can be made by calling the Embassy Suites Cincinnati – River Center at (859) 261-8400. When making your reservation, you must identify yourself as participating in the NRC workshop to receive this government rate. In order to confirm a room assignment, the hotel will require a credit card to guarantee the reservation. Participants in the workshop are encouraged to make lodging reservations with this venue for their convenience and in order to guarantee that they will receive the government rate. Otherwise, individuals should request a Federal Government rate at the hotel of their choice within the Covington/Cincinnati vicinity and within per diem.
