**LODGING AND TRAVEL:** Please plan to arrive on Sunday, August 9, 2015, and depart on Friday, August 14, 2015. Students must make their own lodging and travel arrangements. If traveling by air, please contact El Sol Travel at 1-844-244-6694 for airline reservations, and indicate that the travel is "Invitational" for the NRC. Make sure that El Sol Travel correctly direct bills your fare to credit card ending 2835. You must select a fully refundable government fare. Please complete the Travel Application Form which will be provided to you and submit to Marcia Casby, [ASTrainingandtravel.Resource@nrc.gov](mailto:ASTrainingandtravel.Resource@nrc.gov), at your earliest opportunity, but no later than June 12. Individuals should request the Federal government rate at the hotels. The per diem for Chattanooga, Tennessee is 94/56/150. This means that lodging/meals/not to exceed the total. A complimentary shuttle has been arranged for transportation between the hotel and the training center for individuals staying at the Residence Inn hotel listed below. Those students who elect to stay at an alternate hotel will be responsible for their own transportation between the hotel and the training center.
