### **INSTRUCTIONS TO STUDENTS**

**ACCEPTANCE:** This is to advise you that those individuals in Enclosure 1 have been accepted for participation in the Transportation of Radioactive Materials (H-308) course. This course is scheduled to be presented at the U.S. Nuclear Regulatory Commission's (NRC) Professional Development Center (PDC) April 11-15, 2016. The PDC is located at our 3 White Flint North Building which is situated across Marinelli Road from One White Flint North between the White Flint Metro station entrance and the Metro parking garage. The address for the building is 11601 Landsdown Street, North Bethesda, MD 20852. Please allow sufficient time to process through security upon arrival. You will be required to show proof of identification when you arrive. After you have processed through security, you will be escorted by an NRC employee to the 2<sup>nd</sup> floor where the training will be held.

**COURSE:** Please see our Web site, <u>http://nrc-stp.ornlgov/training.html</u> for the tentative course schedule and note that the course begins at 8:00 a.m. on Monday, April 11, 2016 and ends at 4:00 p.m. on Friday, April 15, 2016.

**LODGING AND TRAVEL:** Please plan to arrive on Sunday, April 10, 2016, and depart on Friday, April 15, 2016. Students must make their own lodging and travel arrangements. If traveling by air, please contact El Sol Travel at 844-244-6694 for airline reservations, and indicate that the travel is "Invitational" for the NRC. Please select a fully refundable Government fare if one is available, and make sure that El Sol Travel correctly direct bills your fare to credit card ending 2835. Flights may be converted to less costly, non-refundable tickets, so please select carefully. If the need arises and you must make a change, please contact Marcia Casby at (301) 415-6525.

Please complete the Travel Application Form which will be provided to you and submit to Marcia Casby, <u>AStrainingandtravel.Resource@nrc.gov</u>, at your earliest opportunity, but no later than Friday, February 12. Individuals should request the Federal government rate at the hotels. The per diem for North Bethesda, Maryland is \$226 hotel and \$69 meals and incidentals. No rental cars will be authorized for travel. The hotel listed below is the most convenient, located on the Metro (White Flint Station on the Red Line), directly across from, and within walking distance of the training site. If you elect to stay at an alternate hotel, you will be responsible for your own transportation between your hotel and the training site. If you plan to drive, the Federal mileage reimbursement is 54 cents per mile.
