ACCEPTANCE: Individuals listed in Enclosure 1 have been accepted for participation in the Sealed Source and Device Evaluation Workshop (G-116) course. This course is scheduled to be presented June 19-23, 2017, at 1201 Umstead Drive, Dorothea Dix Campus, Raleigh, NC 27603. The local airport is the Raleigh-Durham International Airport. **If you have been selected to attend by webinar, separate instructions will be provided to you and the travel guidance provided in this letter will not apply to you.** Please contact Marcia Casby at 301-415-6525 immediately if you are unable to attend this course in Raleigh, NC or by webinar.

LODGING AND TRAVEL: Please plan to arrive on Sunday, June 18, 2017, and depart on Friday, June 23, 2017. Students must make their own lodging and travel arrangements. If traveling by air, please contact El Sol Travel at 844-244-6694 for airline reservations, and indicate that the travel is "Invitational" for the NRC. Please select a fully refundable government fare if one is available, and make sure that El Sol Travel correctly direct bills your fare to credit card ending 2835. Flights may be converted to less costly, non-refundable tickets, so please select carefully. If the need arises and you must make a change, contact Marcia Casby at 301-415-6525.

Please complete the Travel Application Form which will be provided to you and submit to Marcia Casby, <u>AStrainingandtravel.Resource@nrc.gov</u>, at your earliest opportunity, but no later than Friday, April 28. The per diem for Raleigh, North Carolina is \$111 hotel and \$59 meals and incidentals. Taxi fare, including no more than 15 percent for tip, is reimbursable. Rental cars are not reimbursable. You will receive a meal per diem, with the first and last days of travel reimbursed at 75 percent. If you are authorized to drive, the Federal mileage reimbursement is 53.5 cents per mile.
