Dear Mr. Bevill:

We have reviewed the proposed revisions to the Arkansas State Board of Health's Rules and Regulations for Control of Sources of Ionizing Radiation, received by our office on March 13, 2015. These regulations were reviewed by comparison to the equivalent U.S. Nuclear Regulatory Commission (NRC) rules and the requirements of the three amendments identified in the enclosed State Regulation Status (SRS) Data Sheet. We discussed our review of the regulations with Angela Minden on April 22, 2015.

As a result of our review, we have one comment that has been identified in the enclosure. Please note that we have limited our review to regulations required for compatibility and/or health and safety. Under our current procedure, a finding that the Arkansas regulations meet the compatibility and health and safety categories of the equivalent NRC regulation may only be made based on a review of the final Arkansas regulations. However, we have determined that if your proposed regulations were adopted, incorporating our comment and without other significant change, they would meet the compatibility and health and safety categories established in the Office of Nuclear Material Safety and Safeguards (NMSS) Procedure SA-200, "Compatibility Categories and Health and Safety Identification for NRC Regulations and Other Program Elements."

We request that when the proposed regulations are adopted and published as final regulations, a copy of the "as published" regulations be provided to us for review. As requested in NMSS Procedure SA-201, "Review of State Regulatory Requirements," please highlight the final changes, and provide a copy to Division of Material Safety, State, Tribal, and Rulemaking Programs, NMSS.

The SRS Data Sheet summarizes our knowledge of the status of other Arkansas regulations, as indicated. Please let us know if you note any inaccuracies, or have any comments on the information contained in the SRS Data Sheet. This letter, including the SRS Data Sheet, is posted on the NMSS Web site: http://nrc-stp.ornl.gov/rulemaking.html.

Additionally, please note that NRC has previously issued certain security Orders to one Arkansas licensee. We have not listed the name of the licensee in this letter because that information is Official Use Only and cannot be made publicly available. Because the NRC-issued Orders are still legally binding; they must be rescinded by NRC concurrent with Arkansas' promulgation of final regulations. Accordingly, close coordination is needed between the NRC and your office to ensure there are no conflicts, duplications, or gaps regarding the security-related requirements for these licensees. Please contact Adelaide Giantelli, Branch Chief, Source Management, and Protection Branch, NMSS (Adelaide.Giantelli@nrc.gov) for information regarding the affected State licensees and for coordination with rescission of the NRC-issued Orders for this licensee after Arkansas' promulgation and NRC's review of the final Arkansas regulations.

Arkansas has changed the word "Commission" to "Department". As the State cannot determine what is considered special nuclear material under the AEA, Arkansas needs to retain the reference to the NRC. Arkansas needs to make the above change in order to meet the Compatibility Category A designation assigned to 10 CFR Parts 70.4 and 20.1003.
