Dear Mr. Bevill:

We have reviewed the final revisions to the Arkansas State Board of Health's Rules and Regulations for Control of Sources of Ionizing Radiation, received by our office on October 6, 2015. These regulations were reviewed by comparison to the equivalent U.S. Nuclear Regulatory Commission (NRC) rules and the requirements of the three amendments and one provision identified in the enclosed State Regulation Status (SRS) Data Sheet. We discussed our review of the regulations with Kellye Brown-Nichols on November 4, 2015.

As a result of our review, we have no comments. Please note that we have limited our review to regulations required for compatibility and/or health and safety. We have determined that the regulations, as adopted, meet the compatibility and health and safety categories established in the Office of Nuclear Material Safety and Safeguards (NMSS) Procedure SA-200, "Compatibility Categories and Health and Safety Identification for NRC Regulations and Other Program Elements."

The SRS Data Sheet summarizes our knowledge of the status of other Arkansas regulations, as indicated. Please let us know if you note any inaccuracies, or have any comments on the information contained in the SRS Data Sheet. This letter, including the SRS Data Sheet, is posted on the NMSS State Communication Portal: <u>https://scp.nrc.gov/rulemaking.html</u>.

Additionally, please note that NRC has previously issued certain Security Orders to one Arkansas licensee. We have not listed the name of the licensee in this letter because that information is Official Use Only and cannot be made publicly available. Because the NRCissued Orders are still legally binding, they must be rescinded by NRC concurrent with Arkansas' promulgation of final regulations. Accordingly, close coordination is needed between NRC and your office to ensure there are no conflicts, duplications, or gaps regarding the security-related requirements for these licensees. Please contact Adelaide Giantelli, Chief, Source Management and Protection Branch, in NMSS for information regarding the affected Arkansas licensee and for coordination with rescission of the NRC-issued Orders after Arkansas' promulgation of the final Arkansas regulations.
