Dear Mr. Grice:

We have reviewed the proposed revisions to the Colorado regulations pertaining to Radiation Control, 6 CCR 1007-1 Parts 4, 7, 17, and 22 received by our office on June 1, 2020. These regulations were reviewed by comparison to the equivalent U.S. Nuclear Regulatory Commission (NRC) rules and the requirements of Regulation Amendment Tracking System Identification Numbers (RATS IDs) 2020-3, 2021-1, and 2021-2 identified in the enclosed State Regulation Status (SRS) Data Sheet. We discussed our review of the regulations with James Jarvis on June 27, 2022.

As a result of our review, we have no comments. Please note that we have limited our review to regulations required for compatibility and/or health and safety as included in the RATS IDs noted above.

In your letter you also requested clarification for the following items:

- 1) the use of the term "master material license broad scope" in the 10 CFR 35.2 definitions of Authorized Medical Physicist, Authorized Nuclear Pharmacist and Authorized User, and in 10 CFR 35.433(a)(2)(i), as opposed to the term, "master material licensee broad scope" stated in the definition of "Ophthalmic Physicist". You recommend the use of the term, "master material license broad scope".
- 2) the omission of 10 CFR 35.13(b)(4)(i-iv) provisions.

We agree that both of these items appeared to be in error and have referred them to the appropriate staff for correction in a future rulemaking.

Further, you requested that notations be made to the RATS ID 2020-3 sheet to indicate that certain provisions requiring information collection and reporting requirements to the NRC Headquarters Operation Center (HOC) do not apply to Agreement States. We agree that the compatible regulations are for the Agreement State licensees to report to their State regulatory agency. The Commission policy as articulated in the Agreement State Program Policy Statement (82 FR 48535) and NMSS SA-300, *Nuclear Material Event Reporting in the Agreement States*, requires the Agreement State to report these events to the HOC. We have made the notations to the RATS ID sheet for clarification, as requested.

The SRS Data Sheet summarizes our knowledge of the status of other Colorado regulations, as indicated. Please let us know if you note any inaccuracies or have any comments on the information contained in the SRS Data Sheet.
