SUBJECT: FLORIDA COMPATIBILITY DETERMINATION FOR TWO PROPOSED RULE CHANGES

Dear Kevin Kunder:

On September 27, 2023, you requested the Nuclear Regulatory Commission (NRC) provide a compatibility determination for two proposed regulation changes that are required to be adopted as a matter of compatibility. The two changes you proposed are as follows:

1) Definition of Occupational Dose (Compatibility Category A): Would Florida's definition be considered compatible with the NRC's definition if the word "dose" was used instead of plural in the word "doses." Florida's proposed rule language: "Occupational dose" means the dose received by an individual in the course of employment in which the individual's assigned duties involve exposure to sources of radiation, or to radioactive material from licensed or unlicensed sources of radiation, whether in the possession of the licensee, registrant, or other person. Occupational dose does not include <u>a dose</u> received from background radiation, from any medical administration the individual has received, from exposure to individuals administered radioactive material and released as specified in Rule 64E-5.622, F.A.C., from voluntary participation in medical research programs, or as a member of the public.

The NRC determined that Florida's proposed change would not meet the Compatibility Category A designation assigned to 10 CFR 20.1003 Definitions – Occupational Dose. The use of the singular tense of "dose" in the second sentence of the definition is not all encompassing. The reason being is that in the first sentence the singular use of the word "dose" implies a cumulative or total amount received by an individual. In the second sentence we are dealing with multiple scenarios/opportunities where an individual can receive some amount of exposure and all those scenarios need to be accounted for as a total dose, hence the plural use of the word "doses."

- Specialty Board recognition: All rules in Title 10 of the Code of Federal Regulations (10CFR) Part 35 that reference the NRC's specialty board certification process (Compatibility Category B). Florida proposed two rule language options.
  - Option 1: Paragraph (a) would be modified to remove the requirements for an entity to be recognized as a specialty board and replaced with a statement that Florida does not perform specialty board recognition. "(a) Is certified by a medical specialty board whose certification process has been recognized by the Commission or an

Agreement State. The names of board certifications that have been recognized by the Commission or an Agreement State are posted on the NRC's Medical Uses Licensee Toolkit web page. The department does not perform medical specialty board certifications process recognitions."

• Option 2: Florida would retain the current equivalent rule language but add a statement clarifying that Florida does not perform specialty board recognition certifications. "(a) Is certified by a medical specialty board whose certification process has been recognized by the Commission or an Agreement State. The names of board certifications that have been recognized by the Commission or an Agreement State are posted on the NRC's Medical Uses Licensee Toolkit web page. While the department does not perform medical specialty board certifications process recognitions, to have its certification process recognized by the NRC or another Agreement State, a specialty board shall require all candidates for certification to: (1) Complete 700 hours of training and experience in basic radionuclide handling techniques and radiation safety applicable to the medical use of unsealed byproduct material for imaging and localization studies as described in paragraphs (c)(1)(i) through (c)(1)(ii)(G) of this section; and (2) Pass an examination, administered by diplomates of the specialty board, which assesses knowledge and competence in radiation safety, radionuclide handling, and quality control; or."

The NRC determined that Florida's proposed Option 1 would not meet the Compatibility Category B requirements. In 2005, the NRC established a procedure that allows for both the NRC and the Agreement States to recognize certification processes of specialty boards. The requirements that Florida has suggested for deletion in Option 1, apply to the process that must be followed by the NRC or an Agreement State when approving a specialty board and as such Florida should not allow a certification from a specialty board to be used that does not meet those requirements. Therefore, to be compatible, Florida should not make any changes suggested in Option 1.

In Option 2, Florida adding language to state that it does not itself perform specialty board certifications would not impact the overall compatibility of the rule so long as the other language remained intact. Florida's added language does not change the requirements for specialty board recognition across the country and only specifies that Florida does not perform that recognition. Therefore, Option 2 would be deemed compatible.

The SRS Data Sheet in the Enclosure summarizes our knowledge of the status of Florida regulations, as indicated. Please let us know if you note any inaccuracies or have any comments on the information contained in the SRS Data Sheet.
