Dear Mr. Smith:

We have reviewed the final revisions to the Mississippi regulations, Title 15, Part 21, Subpart 78 "Radiological Health," received by our office on May 18, 2017, in which you are addressing the comments from our letter dated July 9, 2013, specifically related to Regulation Amendment Tracking System Identification Numbers (RATS ID) 2001-1, 2004-1, and 2007-3, and other provisions not associated with a RATS ID as identified in the enclosed State Regulation Status (SRS) Data Sheet. We discussed our review of the regulations with Jayson Moak on June 14, 2017.

As a result of our review, we have three comments that have been identified in the enclosure. Please note that we have limited our review to regulations required for compatibility and/or health and safety. We have determined that if these regulations are revised, incorporating our comments and without other significant change, they would meet the compatibility and health and safety categories established in the Office of Nuclear Material Safety and Safeguards (NMSS) Procedure SA-200, "Compatibility Categories and Health and Safety Identification for NRC Regulations and Other Program Elements."

We request that when you revise your regulations to address our comments, a copy of the "as published" regulations be provided to us for review. As requested in NMSS Procedure SA-201, "Review of State Regulatory Requirements," please highlight the location of any changes made by Mississippi, in response to our comments, and provide a copy to Division of Material Safety, State, Tribal, and Rulemaking Programs, NMSS. The SRS Data Sheet summarizes our knowledge of the status of other Mississippi regulations, as indicated. Please let us know if you note any inaccuracies, or have any comments on the information contained in the SRS Data Sheet.
