Dear Mr. Gavitt:

We have reviewed the New York policy and procedure and final regulations for Transportation of Radioactive Materials received by our office on September 23, 2009. These requirements were reviewed by comparison to the equivalent Nuclear Regulatory Commission (NRC) rules in 10 CFR Part 71 and the requirements of the amendment identified in the enclosed State Regulation Status (SRS) Data Sheet. We discussed our review of the regulations with Robert Dansereau on October 22, 2009.

As a result of our rereview of your policy and procedure and regulations submitted in response to Comment 5 of our March 20, 2008, letter, we concluded that the comment stands as noted in the enclosure. Please note that we have limited our review to the regulation requirements required for compatibility and/or health and safety. We have determined that if these requirements are revised, incorporating our comment and without other significant change, they would meet the compatibility and health and safety categories established in the Office of Federal and State Materials and Environmental Management Programs (FSME) Procedure SA-200.

We request that when you revise your regulations to address our comments, a copy of the revised regulations be provided to us for review. As requested in FSME Procedure SA-201, "Review of State Regulatory Requirements," please highlight the location of any changes made by New York, in response to our comments, and provide a copy to Division of Materials Safety and State Agreements, FSME.

The SRS Data Sheet summarizes our knowledge of the status of other New York regulations, as indicated. Please let us know if you note any inaccuracies, or have any comments on the information contained in the SRS Data Sheet. 16.200				New York cites all of 10 CFR 71 by reference in Section 16.17. However in its regulations NY fails to omit those sections specifically designated Compatibility Category NRC (under NRC jurisdiction). NY has taken interim action by issuing a Policy/Procedure to its staff regarding which sections are the exclusive use of the NRC and are therefore not to be enforced. NY needs to add language to 16.17 specifically excluding 10 CFR 71.2, 71.6, 71.13(c) and (d), 71.14(b), 71.19, 71.101(c)(2) (d) and (e), 71.107, 71.109, 71.111, 71.113, 71.115, 71.117, 71.119, 71.121, 71.123, and 71.125.
				New York needs to add language to 16.17 specifically excluding the above sections in order to meet the Compatibility Category NRC designations assigned in 10 CFR 71.
				COMMENT STANDS
				On reevaluation, New York has not exclude in their Compilation of the Rules and Regulations of the State of New York (NYCRR) Title 10 Part 16 the sections that are specifically reserved to NRC jurisdiction. In Section 16.1, New York has only excludes common and contract carriers from the requirements of Part 16. The Policy/Procedure, submitted for NRC's review, which informs New York staff not to enforce these RNC reserved sections is an exercise of enforcement discretion but the regulations impose a duplication of requirements on the New York licensees who are not common or contract carriers since the regulations are on still legally binding
