We have reviewed the final Rhode Island Rules and Regulations for the Control of Radiation which became effective in July 1999. The final regulations are in response to the 17 amendments identified in the enclosed Regulation Assessment Tracking System (RATS) Data Sheet. The regulations were reviewed by comparison to the equivalent NRC regulations in 10 CFR Parts 19, 20, 30, 32, 34 and 35.

As a result of the NRC review, we have one comment that has been identified in the enclosure. As indicated in our September 22, 1999 letter to you, it is our understanding that Rhode Island will adopt the additional language for the definitions of occupational dose and public dose to make them compatible with NRC regulations during your next round of proposed amendments. Our review determined that the remainder of the Rhode Island regulations, as adopted, meet the compatibility and health and safety categories established in the Office of State Programs Procedure SA-200.

We have also summarized on the RATS Data Sheet our knowledge of the status of other Rhode Island regulations. Please let us know if you note any inaccuracies or have any comments on the information contained in the RATS Data Sheet.
