SUBJECT: WASHINGTON FINAL REVISIONS TO RATS ID 2023-1

Dear Earl Fordham:

We have reviewed the final revisions to the Washington regulations Washington Administrative Codes (WAC) 246-100 and 246-252, received by our office on March 22, 2024. These regulations were reviewed by comparison to the equivalent U.S., Nuclear Regulatory Commission (NRC) rules and Regulation Amendment Tracking System Identification Numbers (RATS ID) 2023-1 and as identified in the enclosed State Regulation Status (SRS) Data Sheet. We discussed our review of the regulations with you on April 6, 2024.

As a result of our review we have no comments. Please note that we have limited our review to regulations required for compatibility and/or health and safety. We have determined that the regulations, as adopted, meet the compatibility and health and safety categories established in the Office of Nuclear Material Safety and Safeguards (NMSS) Procedure SA-200, "Compatibility Categories and Health and Safety Identification for NRC Regulations and Other Program Elements."

The SRS Data Sheet summarizes our knowledge of the status of other Washington regulations, as indicated. Please let us know if you note any inaccuracies or have any comments on the information contained in the SRS Data Sheet.
