The Office of Federal and State Materials and Environmental Management Programs (FSME) has reviewed your letter dated January 31, 2007, in response to our letter dated January 9, 2007, which transmitted our comments on Wisconsin's radiation protection final rules in Chapter HFS 157 "Radiation Protection." In your letter, you disagreed with three of the 10 compatibility related comments we made regarding the final rules. We discussed our review of the regulations with Cheryl Rogers and Jason Hunt on February 13, 2007.

The additional information provided in your letter has enabled us to verify that your regulations meet the Compatibility Category B designation for Comment 8 from our January 9, 2007 letter. That comment is withdrawn. Regarding Comments 9 and 10, the Wisconsin rules combined from 10 CFR 35.57(a)(1) and (2) into Chapter HFS 157.61(10). Paragraphs 35.57(a)(1) and (2) identify certain medical professionals who are excepted from the training requirements in §\$35.50, 35.51, and 35.55. The medical professionals excepted by paragraphs 35.57(a)(1) and (2) are defined based on both how they are identified in certain Agreement State and NRC licenses, and when such licenses were issued. We acknowledge that Wisconsin became an Agreement State on August 11, 2003, and that some of the reference dates in §35.57 refer to time periods prior to 2003. However both §35.57 and HFS 157.61(10) refer to individuals who may have been identified in licenses issued by other regulators (i.e. NRC or other Agreement States) during these time periods. Therefore, the reference dates in paragraphs 35.57(a)(1) and (2) are relevant and must be included in HFS 157.61(10) in order to meet the Compatibility Category B criteria which requires adoption of an essentially identical rule.

The attached table shows the nine outstanding comments that need to be incorporated into Wisconsin's final regulations and the one withdrawn comment which requires no action by Wisconsin.

The attached SRS Data Sheet summarizes our knowledge of the status of other Wisconsin regulations and legal binding requirements, as indicated. The suggested updates to the SRS Data Sheet will be made as you requested in your January 31, 2007 letter. Please let us know if you note any additional inaccuracies, or have any comments on the information contained in the SRS Data Sheet.
